Repeated, prolonged exposure to respirable crystalline dusts may increase the risk of developing a disabling lung disease called silicosis. The International Agency for Research on Cancer (IARC) reports there is sufficient evidence in humans for the carcinogencity of inhaled crystalline silica from occupational sources. Based on studies of workers in industrial and occupational settings, The National Toxicology Program (NTP) Ninth Report on Carcinogens lists crystalline silica (respirable) as a substance known to be a carcinogen to humans.
