6. Accidental Release Measures

Spill and Leak Procedures

Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture as they are released into the atmosphere in sufficient concentrations. Avoid dispersal of dust in the air (e.g., cleaning dust from surfaces with compressed air).
