Chemical Name: Compounded emulsified formulation that forms a “plastic skin” preservative coating. **Name: *SILKENSEAL™***

Carcinogenicity: Carcinogenic chemicals not part of formulation

Ingestion: Potentially harmful if swallowed in large amounts. If victim is conscious, give two glasses of water to drink and consult a physician. Do not give anything by mouth to an unconscious person.

Appearance: White emulsion.

ACCIDENTIAL RELEASE MEASURES

Stop spill at source, prevent run off. Mop, shovel, pump and/or absorb with inert material (“kitty litter”). Place in sound containers, Clean ground with detergent and rinse off with excess water.

Waste disposal: not regarded as a hazardous waste, but dispose according to appropriate federal, state and local regulations.

Special Protective clothing or respirators:

Not generally necessary, but eye and hand protection always advisable. Avoid Skin and eye contact, do not ingest liquid product or inhale aerosolized mist.

Special precautions: Leaves floors slippery - use “kitty litter” or similar if spilled (even after clean up). ***Keep out of reach of children***
